No.SO(Juld)/HD/P-500/2019/Vol-I In exercise of the powers conferred by sub-section (1) of section 14-A of the Code of Criminal Procedure, 1898 (V of 1898), and in continuation of all previous notifications issued in this behalf, the Government of the Khyber Pakhtunkhwa is pleased to appoint and confer on all the Assistant Commissioners and Additional Assistant Commissioners in the Khyber Pakhtunkhwa Province the powers of Special Magistrate 1<sup>st</sup> Class to try offences relating to price control, forest, mines and mineral, food adulteration, food safety, encroachments on public lands, water ways, canal and drainage, motor vehicles, building control and municipal services under any Provincial or Federal law, for the time being in force with immediate effect.

2. Government of the Khyber Pakhtunkhwa in pursuance of sub-section (2) of Section 14-A of the Act ibid is further pleased to authorize all Deputy Commissioners in the Khyber Pakhtunkhwa to define, from time to time, local areas within which such Special Magistrates 1<sup>st</sup> Class may exercise all or any of the powers with which they are invested under any Provincial and Federal law, relating to the matters as specified in Para-1 above.
